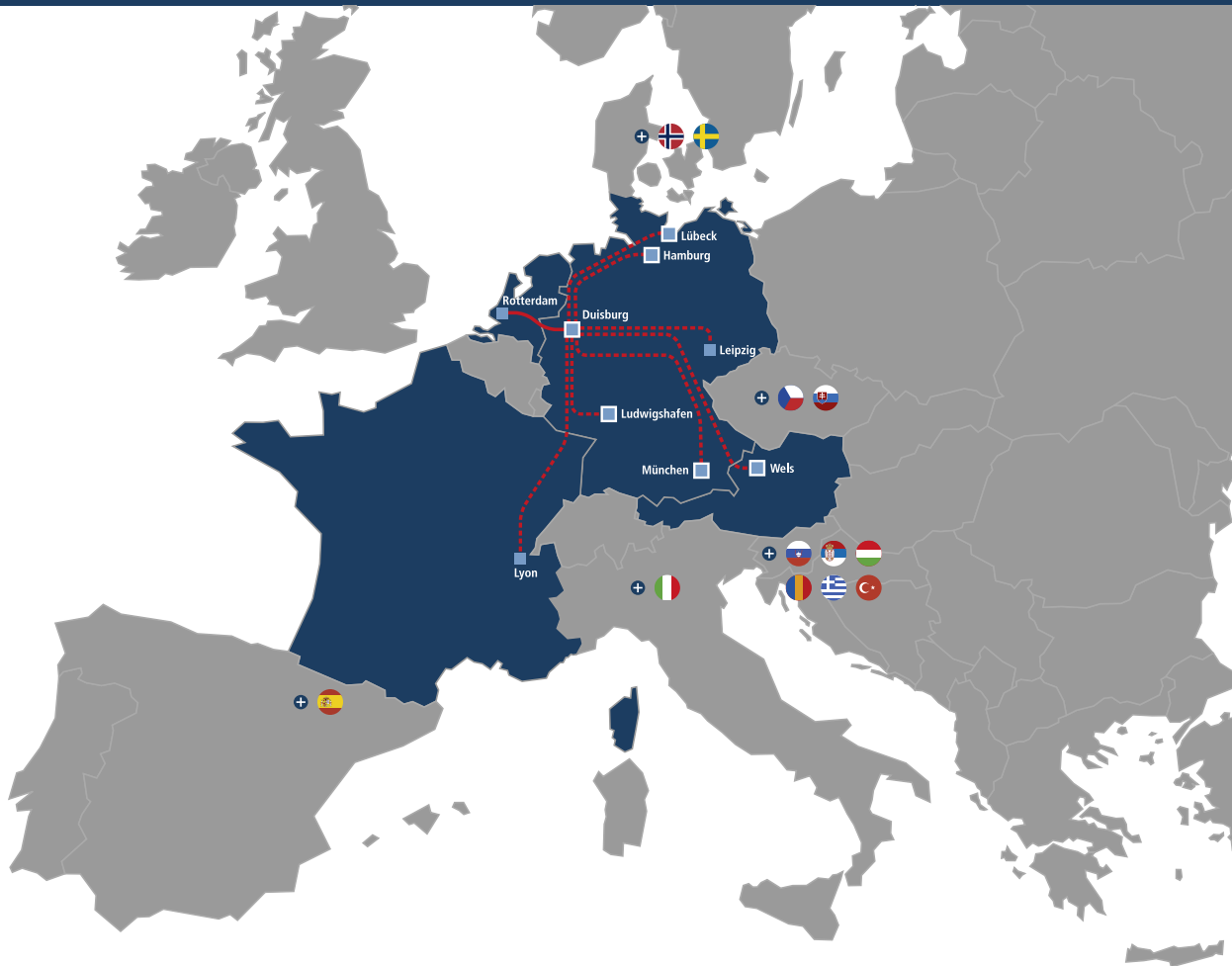

CUSTOMS

For goods subjects to customs, the details of the type of customs procedure and, if applicable, a valid Movement Reference Number (MRN) must be provided during the online booking process. The creation and processing of customs documents are not offered by Kombiverkehr. We are happy to assist you in finding a customs agent.

DANGEROUS GOODS & WASTE

The transport of dangerous goods is basically possible. Exceptions are dangerous goods with UN number 1005, 1017, 1026, 1048, 1050, 1051, 1053, 1067, 1069, 1076, 1082, 1259, 1614, 2480, 2188, 2192, UN 2199, 2202, 2204, 2418, 2481 & UN 2676. For class 1 dangerous goods, please contact ulueck@kombiverkehr-gefahrhut.de. In general, loading units with dangerous goods must be collected on the day of arrival and delivered on the day of departure. DELIVERY & PICK UP

The pick-up requires the indication of the loading unit number and/or an exemption code. The exemption code can be found in the order overview in [myKOMBIVERKEHR](#) as well as in [Cesar NEXT](#). Alternatively, a collection can be made using a unique customer reference, which you can enter when booking.

For collection and delivery, the driver must provide the CT-UIRR order number as a reference in addition to the ILU code of the unit. For gateway shipments, this is taken from the CESAR Next system.

The carrier Carrier pre-notifies all drop-off and pick-up containers via Portbase MCA. Carrying a CargoCard is mandatory at the Rotterdam terminal. Due to increased security regulations, every truck driver now needs this card to enter the terminal. The CargoCard can be requested on the following website: www.secure-logistics.nl/nl/oplossingen/cargocard/ . IMPORTANT:

Kombiverkehr cannot issue this card for you.

In the case of non-EU goods, the seals on the loading unit and the accompanying documents required for rail transport (customs documents, commercial invoices, etc.) must be made known to the agency employees or handed over to them at the latest on delivery.
