BENEFITS FOR LIMITED PARTNERS

You will find the specific criteria for using these transport services and other detailed information in the respective version of the national and international Price Regulations.

REQUIREMENTS

WHO CAN BECOME A LIMITED PARTNER?

Any transport company and any forwarder working in the combined freight transport sector can become a limited partner of Kombiverkehr.

WHAT ARE THE FORMALITIES?

An informal request to join us as a limited partner is sufficient and can be sent at any time. Once we have received your request, we will send you our declaration of accession. Please return this to us, together with an up-to-date certificate of registration. Both documents must be notarised or legally certified.

Two further requirements for becoming a limited partner are the payment of the partnership contribution, which currently stands at EUR 16,000, and participation in the Kombiverkehr deferral arrangement. You will find more information on the deferral arrangement, which allows you to pay transport costs at a later date by extending credit, at www.kombiverkehr.com > Service > New at Kombiverkehr? > Becoming a customer.

Once all the formalities are complete, the Administrative Board of our company will make a decision on your application for acceptance.
